Course Description

This course is required of all accounting majors. It covers accounting and financial reporting practices of state and local governments and other not-for-profit entities.

Course Objectives

The objective of this course is to educate prospective accountants, public administrators, and other professionals with regard to governmental and not-for-profit accounting and financial reporting. Areas of emphasis include

- 1. Actual and budgetary accounting at the fund level for governmental funds on the modified accrual basis.
- 2. Accounting for proprietary and fiduciary funds of governmental entities.
- 3. Preparation and interpretation of government-wide financial statements on the full accrual basis.
- 4. Accounting and reporting for colleges and universities, hospitals, and other health care providers.
- 5. Examination of the Single Audit Act and related ethical issues.

Course Delivery Method

I will conduct class during our scheduled class time. All tests will be administered in our classroom on the scheduled dates noted in the topical outline below. I expect you to follow the topical outline and assignments schedule on a daily basis.

Grading

I will deduct five points from your grade for each absence after your third absence (excused or unexcused).

Assignment Submission

This course requires reliable internet access for completion and grading of homework. You must be willing to prepare your homework at a UCA computer lab if your personal internet access is not working or if you do not have personal access. General computer problems and internet access problems will not be an excuse for missing homework assignments.

Makeup Exams

Examinations will involve a variety of teaching methods – from multiple choice to short answer to essay. All students must take the final exam as scheduled unless an incomplete contract has previously been approved according to university regulations. It is to your advantage to take all exams at the scheduled times. Only in the case of a well-documented true emergency should an exam be missed. You must have prior approval for missing an exam. Exams missed without the prior approval or without adequate documentation of the reason for missing the exam will result in a recorded grade of zero for the missed exam.
