Course Description:

Finance 2330 (Personal Finance) will introduce you to concepts, tools, and practical applications of personal finance. This course will help you to understand the ins and outs of personal finance and how they impact our daily lives.

Course Objectives:

- To discuss tools and techniques used when making financial decisions.
- To use tools and techniques learned to solve day-to-day challenges.
- To learn how to develop a complete personal financial plan.

Course Delivery Method: Lecture, problem sets, class discussion
