Course Description:

Every organization, from manufacturing to service, whether for-profit or nonprofit, must understand the cost of what they provide to their clients. Company profitability and customer profitability depends on management's knowledge of and ability to plan and control costs. Cost accountants use standardized and improvised practices to collect, analyze, and summarize timely, useful cost information.

Course Objectives:

- Prepare students to become integral members of decision making teams instead of just data providers, by developing skills to analyze and manage costs and an understanding of costing that leads to strategic decision-making.
- To develop problem-solving skills including the abilities to define the problem, select tools to solve the problem, work through a solution, and evaluate the solution to make a plan of action.
- To develop study skills and techniques that will lead to successful and life-long learning.

Course Delivery Method:

Content for this course will come from the textbook, in-class lectures, and additional materials on Blackboard.

Grading:

550 points are possible. Accumulated points determine course grade: A>495; B>440; C>385; D>330; F<330.

Exams (500 points): Four chapter exams and one cumulative final exam, each worth 100 course points, will be given.

Budget Project (50 points): The budget project replaces testing of Chapter 8. You may complete it individually or with one other student. It must be completed in Excel and submitted via Blackboard and on paper.

Homework Problem Sets (Possible Bonus Points): A problem set is assigned after each lecture. Problem sets have due dates and should be completed in CengageNow. Problem sets are optional but highly recommended for practice and mastery of coursework. Your homework can lead to bonus points; for example, if there are 5 bonus points on Exam 1 (Ch 1, 2, &3), and you earned 80% on Ch 1, 2, & 3 homework, you get 4 bonus points (5x 80%). Bonus points for the final exam will come from Chapter 16 homework and participation in Accounting Department events.

Description of Major Deliverables/Course Requirements:

This class covers chapters 1-10 in the traditional lecture format, and Chapter 16 will be an independent study chapter. Students should plan to study and complete homework for Chapter 16 sometime after the first exam and before study day. Chapter 16 will be covered on the final exam.

Evaluations:

Student evaluations of a course and its professor are a crucial element in helping faculty achieve excellence in the classroom and the institution in demonstrating that students are gaining knowledge. Students may evaluate courses they are taking starting on the Monday of the thirteenth week of instruction through the end of finals week by logging in to myUCA and clicking on the Evals button on the top right.

Policies and Procedures:

Rounding Rules:

Follow rules in CengageNow. Otherwise apply the following rules when rounding:

- Always divide last (e.g., 2 minutes per unit×100 units÷60 minutes in an hour; NOT 2÷60×100)
- Money>\$5 should be rounded to two decimal places.
- Money<\$5 should be rounded to four decimal places.
- Percentages should be rounded to 4 decimal places.
- Units should be rounded up to the next whole unit.

Attendance and Timeliness Policy:

- Attendance is taken every day, but is not used in grade calculations.
- Students who are late to class on a regular basis will be warned and then asked not to return.

• Students who routinely miss class will be dropped for nonattendance if they have not made progress toward the completion of the class by the first exam.

Missed Assignments:

Homework and Budget Projects will not be accepted late.

Missed Exams (Cumulative Final):

- If you have a planned absence, you may take your exam early at the instructor's discretion.
- No make-up exams are given. Students may miss one test; no excuse necessary.

• The cumulative final will replace a student's low chapter exam grade (if final exam grade is higher). It may replace a low grade or a grade of zero for a missed test. The final is required and counts for 100 points; if replacing another test, it will count for 200 points.

• Bonus points on the final do not double; they apply to the final only.

Classroom Behavior and Electronics:

- Use of any device that records voice and or image is prohibited in class without permission.
- Other electronic devices are permitted for course purposes.
- Students should respect the teacher and classmates and make every effort to eliminate disruptions.
- Student who disrupt class or distract classmates for any reason will be warned and then asked not to return.

Examination Policies:

- You may not leave the classroom during an exam.
- Allowed items: writing implements, erasers, calculator (non-programmable), and a watch (not web or cellular enabled).
- All other personal items must be left at the front of the room during an exam including your cell phone and pencil cases.

➤ Students who are in possession of a prohibited item during an exam will receive a zero on the exam and may be subject to the academic dishonesty policy.

University Closure Contingency Policy:

Should the University close for any reason other than scheduled holidays causing this class to be cancelled for more than one day, the following policy will take effect.

- Homework will still be due as scheduled.
- Depending on the duration of the closure, exams may be rescheduled or taken online.

Situations that prevent a student from participating in the online lectures will be addressed on an individual basis.
